C. **ATHLETE ELIGIBILITY**

All athletes must comply with the provisions of the Olympic Charter currently in force, including but not limited to, Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement





Code on the Prevention of Manipulation of Competitions). Only those athletes who comply with the Olympic Charter may participate in the Olympic Games Tokyo 2020.

Additional IF Eligibility Criteria:

Only the athletes who are eligible to participate at the official FINA Competitions, in accordance with the <u>FINA Rules GR 2.5</u>, are entitled to participate in the Olympic Games Tokyo 2020.

The qualification events are listed in chronological order of qualification.

1 place (11 athletes)	18 th FINA World Championships 2019 – Gwangju (KOR) The highest placed team from the women's competition at the 18 th FINA World Championships 2019 will obtain a quota place. If this team has already qualified from the 2019 World League, the next highest placed team from the World Championships qualifies. (FINA BL 9.3.10.3.3)

(11 athletes)	The Host Country NOC will automatically obtain a quota place.	
	(FINA Rule BL 9.3.10.3.4)	
5 places (55 athletes)	Continental Championships/Host Country The highest placed NOC in each of the five (5) Continental Championships will each obtain a quota place. If the NOC is already qualified at the preceding year's World League (BL 9.3.10.3.2), or at the preceding FINA World Championships (BL 9.3.10.3.3), then the next highest placed team from the respective Continental Championships will qualify. (FINA Rule BL 9.3.10.3.5)	
	Should any of the Continental Championships not take place, a play-off match between the top two (2) teams from the respective continent will be organised to determine which NOC would represent the specific Continent.	
	Should there only be one representative from a specific continent, this NOC will obtain a quota place.	
2 places (22 athletes)	Olympic Games Qualification Tournament The two (2) highest placed NOCs at the Olympic Games Qualification Tournament will each obtain a quota place. The teams that are eligible to take part in the qualification tournament is specified in FINA Rule BL 9.3.10.3.6.	





HOST COUNTRY PLACES

The Host Country is guaranteed one (1) team quota place per gender.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

CONFIRMATION OF QUALIFICATION PLACES

Following each qualification event, FINA will publish the results on its website (http://www.fina.org/) and inform the respective NOCs of their allocated quota places.

The NOCs will then have 21 days to confirm if they wish to use these quota places, as detailed in paragraph **G. Qualification Timeline**.

CONFIRMATION OF HOST COUNTRY PLACES

The Host NOC has to confirm the use of the allocated quota places to FINA two (2) weeks after the end of the qualification tournament.

F. REALLOCATION OF UNUSED QUOTA PLACES

REALLOCATION OF UNUSED QUALIFICATION PLACES

Any unused quota places will be reallocated to the next highest placed NOCs according to the ranking of the Men's Olympic Games Qualification Tournament (FINA Rule BL 9.3.10.1.7) or the Women's Olympic Games Qualification Tournament (FINA Rule BL 9.3.10.3.7), as applicable.

REALLOCATION OF UNUSED HOST COUNTRY PLACES

Any unused Host Country quota place will be reallocated to the next highest ranked NOC, not yet qualified, according to the ranking of the Continental Championships (for Asia).
